PHILADELPHIA DHS BURIAL GRANT APPROVED FUNERAL HOMES

The Department of Human Services will provide payment for burial and cremation services on behalf of eligible individuals. Those who are:

- Individuals who received Supplemental Security Income or SSI
- Individuals receiving cash benefits from the department of Human Service prior to death
- Individuals who were found eligible for cash assistance prior to death
- Residents of nursing homes who received SSI or nursing care payments prior to Jan 1, 1973, continuously to present

A funeral director must be registered as a provider with DHS in order to receive payment. Below is the list for Philadelphia. You may request a list from any county here: <u>local county assistance</u> offices (CAOs).

BURIAL ASSISTANCE (VETERAN)

- I. How to Apply
 - Online: https://www.va.gov/burials-memorials/veterans-burial-allowance/
 - Mail: Mail completed form to nearest VA regional Office: Download the form at: https://www.va.gov/burials-memorials/veterans-burial-allowance/
 - Call for questions: If you have questions, call <u>800-827-1000</u>. Monday through Friday, 8:00 a.m. to 9:00 p.m.
- II. You may be able to get veterans burial allowances if you're paying for the burial and funeral costs and you won't be reimbursed by any other organization. The following are further requirements:
 - One of these relationships or professional roles describes your connection to the Veteran. You are:



- a. The Veteran's surviving spouse (**Note:** we recognize same-sex marriages), **or**
- The surviving partner from a legal union (a relationship made formal in a document issued by the state recognizing the union), or c.A surviving child of the Veteran, or
- d. A parent of the Veteran, **or**
- e. The executor or administrator of the Veteran's estate (someone who officially represents the Veteran)
- The Veteran must not have received a dishonorable discharge, and one of these circumstances must be true. The Veteran died:
 - As a result of a service-connected disability (a disability related to service), or
 - b. While getting VA care, either at a VA facility or at a facility contracted by VA, **or**
 - c. While traveling with proper authorization, and at VA expense, either to or from a facility for an examination, or to receive treatment or care, **or**
 - d. With an original or reopened claim for VA compensation or pension pending at the time of death, if they would've been entitled to benefits before the time of death, **or**
 - e. While receiving VA pension or compensation, or
 - f. While eligible for VA pension or compensation at time of death, but instead received full military retirement or disability pay

Or the Veteran:

- a. Had been getting a VA pension or compensation when they died, **or**
- b. Had chosen to get military retired pay instead of compensation

Note: allowance for the cost of transporting a veteran's remains for burial in a national cemetery is also provided.

You can't get burial allowances for certain individuals

- a. Burial allowances not provided if the individual died:
 - 1. On active duty, or
 - 2. While serving as a member of Congress, or
 - 3. While serving a federal prison sentence

III. Time limit for filing?

- You must file a claim for a non-service-connected burial allowance within 2 years after the Veteran's burial or cremation. If a Veteran's discharge was changed after death from dishonorable to another status, you must file for an allowance claim within 2 years after the discharge update.
- There is no time limit to file for a service-connected burial, plot, or interment allowance.

IV. Available burial benefits

- o For burial in a national cemetery, you'll receive an allowance for:
 - a. Burial and funeral costs
 - b. The plot (gravesite) or interment



- c. Transporting the Veteran's remains for burial
- The Veteran's family will need to cover the cost of funeral director services, like cremation.

V. Documents needed along with my application

- The Veteran's military discharge papers (DD214 or other separation documents)
- The Veteran's death certificate
- Any documents or receipts you have for the cost of transporting the Veteran's remains
- A statement of account (preferably with the letterhead of the funeral director or cemetery owner) that has this information:
 - a. The Veteran's name, **and**
 - b. The type of service or item purchased, and
 - c.Any credits, and
 - d. The unpaid balance
- VI. You don't need to file a claim as a surviving spouse, as long as you're listed as the Veteran's spouse on the Veteran's profile. Once VA receives notice of the Veteran's death, a set amount to those eligible surviving spouses to help pay for the plot, the cost of interment, or transportation of the remains to the cemetery is automatically paid.
