# WHAT IS IT

- Standardized reporting of membership, attendance and finances
- A means of tracking important statistics for church, diocese and TEC
- Due March 1st

- Red Service Book
- Current Membership Roles
- Year End Financials (budget, bank/investment statements)
- Current Stewardship Information (pledge cards)
- Previous Year's Parochial Report

- Financial Wardens
- Clergy (or Senior Warden)
- Secretary of the Vestry
- Whole Vestry

#### **CHANGES FOR 2020**

- The Parochial Report is very much a work in progress
- The pandemic created some particular challenges
- Record/Report on attendance only from Jan I-March I 2020
- Virtual attendance/engagement will still be reported but not entered into the stats
- Specifies where PPP money should be entered
- Added a narrative section on how the church responded to the pandemic

- Before submitting the whole vestry should review the report
- Submit Online
- Send signed copy via mail to the Offices of the Diocese
