The Episcopal Diocese of Pennsylvania October 2024 Financial Reports Executive Summary

1. Sacred Ask Receivable – Total received through October 2024 is \$2,302,420 which is \$330,663 lower than the prorated budget of \$2,633,083.

2. Budget Variances

- Revenues
 - i. Sacred Ask Receipts are less than prorated budget
 - ii. Endowment Distribution YTD distributions are 5% less than budgeted
 - iii. Allocated Endowment Distribution Increase in Christmas Fund Transfer
 - iv. Other Revenue Special Increase in Flagg Trust Income and Interest Income from short term investments
- Empowering Churches
 - i. Canons for Growth & Support and Mission vacant positions
 - ii. Diocesan Center Facilities Utilities, Insurance, grounds maintenance exceed budget
 - iii. Diocesan Convention & Events General Convention expenses exceeded budget
- Stabilization and Growth
 - i. Acts 2 Churches Vicars Vacant positions
 - ii. Clergy Financial Assistance & Sabbatical Leave Fewer requests than budgeted
- Fostering Innovation:
 - i. Growth Development Fund Grants St. Dunstan's unpaid award returned to fund
 - ii. Support for Congregations Diocese covered old clergy pension in arrears, increased need for support among churches
- Support Expenses
 - i. Legal, Professional & Audit Increase in legal and professional fees
 - ii. Operations Donations exceeded budget
 - iii. Closed Church Property Repairs and higher seasonal costs, increase in closed churches

3. Overall Performance

• The YTD deficit of \$(718,726) is more than the YTD budgeted deficit of \$(402,299), resulting in an unfavorable variance of \$(316,427). The deficit is due to lower than budgeted Sacred Ask receipts, Facilities costs, Closed Church Property expenses, partially offset by increased revenues from Interest Income and Christmas Fund Transfers.

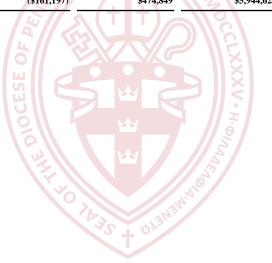
